1. ABSTRACT

The LIFE PINNARCA project (LIFE20-NAT/ES/001265), developed with the contribution of the LIFE Programme of the European Union, aims to conserve the fan mussel (*Pinna nobilis*), a critically endangered bivalve mollusc. A fundamental aspect for the protection and recovery of the species is the dissemination of the problem along with the participation of citizens and the different sectors involved, with special emphasis on environmental improvement and the creation of synergies with other ecological conservation initiatives at national and international levels.

A good way to raise public awareness and disseminate results is to design a mascot that helps to better identify the PINNARCA project. In basic terms, a mascot is a character, a personified image that becomes a symbolic representation of a brand, company, or even a European project. Therefore, a contest was carried out and the public was invited to participate.

The purpose of this contest was to create a design of a mascot meant to be the European image of the "LIFE PINNARCA" project, achieving an identification sign of the project. Once the contest is over, the chosen mascot will be used as a companion in the dissemination of the project information through different channels: written documents, t-shirts, posters, websites, social networks, etc.

- Each participant may submit a maximum of 3 proposals to the contest. It should be taken into consideration that the design of the mascot will be used in different sizes and formats, so it must be recognizable both in medium sizes and in smaller formats.
- The partner organizations of the "LIFE PINNARCA" project hold the right to publish and disseminate the winning work.
- Participation in this contest and the submission of a proposal implies acceptance of the terms and conditions established in these bases.

The preselection of proposals was taken place on April 28, 2022 and was publicly announced at the meeting in the "Veles e Vents" building of the Royal Marina of Valencia of the partners of the "LIFE PINNARCA" project. Before May 30, 2022 the jury final decision was communicated to the winner through the same e-mail address from which the proposal was sent. The winner received an economic remuneration of € 4000 gross. In addition, the winner is going to have other recognitions such as the publication of their name on the web pages / social networks of the partner organizations. As mentioned above, the mascot is going to be used in a variety of media such as t-shirts, brochures, social media posts, posters, and the different kinds of informative material.

There was an evaluation criteria to select the final mascot. The points to be considered were as follows:

- 1. The design of the mascot should be visually appealing and expressive.
- 2. The mollusc *Pinna nobilis* should be recognizable in the design.
- 3. It should reflect the European nature of the project.
- 4. The design must be original and unpublished, thus certifying that the images have no use restrictions.
- 5. The creativity, originality and adaptation of the mascot with the characteristics of the project described above will be the main valued features.

3. FINALIST PINNARCA-MASCOT-LOGO CONTEST


Figure 1. Evaluation criteria of mascot design contest

A total of 33 candidates with 41 proposals were received. After reviewing all proposals, each member of the jury evaluated each of the proposals submitted using a score table. The score table presented the evaluation criteria divided in different sections: appropriateness to the subject (30%), ability to be exploited (20%), visual attractiveness (15%), originality (10%), creativity (10%), artistic value (10%) and humour (5%). The rate item was between 1 point (bad) and 10 (excellent). The total score was the result of the specific weighting of the different items (Figure 1). In Annex II can be found the link with all proposals and the excel files with the scores from each member of the jury.














Figure 2. Finalist proposals chosen by the jury

Finally, the members of the jury selected five finalists' proposals for the next phase (Figure 2). The five finalists of the contest were Aurélie VION, Ferran España, José Villota, Vandamme Laetitia, Vicent Santamaría, by alphabetic order.

After the election of these five designs, the jury voted again among these five proposals. The design by Ferran España received 50% of the votes (2 votes) of the jury. Another two designs received 25% of the votes (1 vote) each. Furthermore, before final decision, the jury asked for the input of the LIFE PINNARCA partners on the five finalist proposals with the goal of considering their opinion (scores between 1 (bad) to 5 (excellent)). The option with a higher score voted by the partners was, again, the proposal from Ferran España (Table 1).








Finalist Mascot:
